INTRODUCTION

International organizations are effective regulators of international relations, particularly in the economic sphere. Their importance as institutional units of the international economy is growing. Currently, almost all states of the world - from the most powerful to small and those whose economic level is still low - are combined in the global network of international organizations. The process of globalization, which spreads relentlessly and covers almost all spheres of economic activity, creates conditions for the formation of supranational structures for the regulation of economic relations, and international organizations are the most active instrument of such regulation. In addition, it is worth considering the practical activity of Ukraine in international organizations and the prospects of its involvement in a wide range of communities.

Ukraine is a member of many interstate organizations, and it is included in most of the most authoritative global organizations, building mutual relations on the principles of equality, justice, democracy and observance of national interests.

The academic discipline "International Organizations" is a compulsory academic discipline and is studied in accordance with the curriculum for training specialists of the "Bachelor" level of education, specialty 292 "International Economic Relations" of all forms of education and is aimed at forming general foundations for the analysis of patterns and features of the development of international organizations, obtaining the necessary knowledge on issues of regulation of international activities by these organizations at the supranational level.

The goal of teaching the academic discipline "International Organizations" is the formation of a system of special knowledge on the problems of the formation of students modern economic thinking and the system of special knowledge about the role and functioning mechanisms of international organizations, familiarization with the regularities of their activity.

The main tasks of studying the discipline "International Organizations" are:

acquiring knowledge about the regularities and features of modern international organizations;

mastering the skills of researching the state of international economic, political, and social integration;

understanding the mechanisms of influence of international organizations on the process of globalization of the world economy.

TEACHING METHODS

In the process of teaching the academic discipline "International Organizations" for the acquisition of specified learning outcomes, the activation of the educational process, the use of such learning methods is provided, such as:

Verbal: introductory lecture (Topic 1), review lectures (topics 2-9), problem lecture, discussion (Topic 10)

Face-to-face: demonstration of presentations on topics 1-10, demonstration of film-video clips on topics: 3, 4, 6, 8

Practical: practical and laboratory works on topics 1-10, work in groups on topics 3 and 8, role-playing on topic 10.

FORMS AND METHODS OF ASSESSMENT

The University uses a 100-point cumulative system for assessing the learning outcomes of students.

Current control is carried out during lectures, practical, laboratory and seminar classes and is aimed at checking the level of readiness of the student to perform a specific job and is evaluated by the amount of points scored:

- for courses with a form of semester control as grading: maximum amount is 100 points; minimum amount required is 60 points.

The final control includes current control and assessment of the student.

Semester control is carried out in the form of a semester exam or grading.

The final grade in the course is determined:

- for disciplines with a form of grading, the final grade is the amount of all points received during the current control.

Final control includes semester control and certification of the student of higher education.

Semester control is conducted in the form of a credit.

During the teaching of the course, the following control measures are used:

Current control: practical and laboratory works (maximum score – 100 points).

Semester control: Grading

More detailed information on the assessment system is provided in technological card of the course.
