### INTRODUCTION

The deepening of international cooperation makes it possible to use world experience in the implementation of economic activities. This determines the growth of the role of international trade and its study in the context of the development of the modern economy.

The study of the course "International trade in goods, services, technologies" is aimed at mastering the trends in the development of international trade in goods, services, technologies and the development of the international economy of the countries of the world; formation of practical skills regarding the analysis of events in modern international economic relations and further use of acquired skills in enterprise management.

The course "International trade of goods, services, technologies" is a mandatory educational discipline and is studied in accordance with the curriculum for training of bachelor's first degree students of speciality 292 "International Economic Relations" educational program "International Business" of all forms of education.

The purpose of the course is the formation of a system of knowledge, skills and practical skills regarding the theoretical foundations and methodological and practical tools related to issues of development and the current state of international trade in goods, services, and technologies.

The tasks of the course are the formation of general foundations for the education seeker in the analysis of patterns and features of the development of international trade in goods, services, technologies, obtaining the necessary knowledge on the activities of leading countries in foreign economic activity, features of international relations, economic phenomena and processes in the international sphere based on an understanding of categories, laws; highlighting and summarizing trends, patterns of functioning and development of the world economy, taking into account cause-and-effect and space-time relationships.

The object of study of the course is the process of determining the functional features and relationships in the international markets of goods and services, tools and principles of regulation of international trade, monitoring the state of world markets, evaluating changes in the international environment.

The subject of the course is the principles, forms and methods that allow solving complex specialized tasks and practical problems in the field of international relations, as well as applying information and analytical tools, economic and statistical calculation methods, complex analysis techniques and methods of monitoring the state of world affairs markets, apply modern theories and methods of solving specialized complex problems and practical problems in the field of international trade in goods and services, international movement of capital, international currency, financial and credit relations, mobility of human resources, international technology transfer

### **TEACHING METHODS**

In the process of teaching the course, in order to acquire certain learning outcomes, to activate the educational process, it is envisaged to use such teaching methods as:

Verbal (lecture (Topic 4, 6, 7, 8), problem lecture (Topic 1, 9), lecture-discussion (Topic 2, 3, 5)).

Visual (demonstration (Topic 1 - 9)).

Practical (practical work (Topic 1 - 9), laboratory (practical work (Topic 1 - 9)).

### FORMS AND METHODS OF ASSESSMENT

The University uses a 100-point cumulative system for assessing the learning outcomes of students.

**Current control** is carried out during lectures, practical, laboratory and seminar classes and is aimed at checking the level of readiness of the student to perform a specific job and is evaluated by the amount of points scored:

— for courses with a form of semester control as an exam: maximum amount is 60 points; minimum amount required is 35 points.

The final control includes current control and an exam.

**Semester control** is carried out in the form of a semester exam or grading.

The final grade in the course is determined:

— for disciplines with a form of exam, the final grade is the amount of all points received during the current control and the exam grade.

During the teaching of the course, the following control measures are used:

Current control: practical or seminar tasks on topics 1, 5, 7, 9 (5 points), laboratory classes on topics 2, 3, 4, 6 (5 points), two written control papers on content modules (5 points each), individual educational and research tasks on topic 8 (10 points). By completing written tests, students solve problematic issues related to the development of international trade in goods, services and technologies, as well as perform test tasks

on the topics of the relevant modular units.

Semester control: Grading including Exam.

### Recommendations for the solution.

- 1) The trade balance is defined as the difference between the value of exports (E) and imports (I) of the country for a certain period. Active trade balance is the excess of exports of goods and services over imports. It shows that foreign trade relations are positive for the country. Passive trade balance is an excess of the country's imports over exports.
- 2) Foreign trade turnover (FTO) is the sum of the value of exports and imports of the country for a certain period.
  - 3-4) Relative share is calculated as specific gravity

### Evaluation criteria

The final marks for the exam consist of the sum of the marks for the completion of all tasks, rounded to a whole number according to the rules of mathematics.

The algorithm for solving each task includes separate stages that differ in complexity, time-consumingness, and importance for solving the task. Therefore, individual tasks and stages of their solution are evaluated separately from each other as follows:

### Task 1 (test). (30 points)

For each correct test, if calculations are available - 3 points.

## Task 2 (stereotype). (4 points)

1 - answer each open question.

## Task 3 (diagnostic). (6 points)

- 2 calculated trade balance;
- 2 calculated foreign trade turnover;
