INTRODUCTION

Foreign economic activity is an important component of the economic activity of economic entities, as the relationship between national and foreign entities is becoming more and more relevant. Therefore, the use of the latest forms and methods of foreign economic activity has a positive effect on the efficiency of the country, region, and enterprise. Access to foreign markets contributes to the improvement of world economic relations, the development of an open economy; therefore, the development of foreign economic activity is a significant factor in increasing efficiency.

The purpose of the educational discipline is the formation of a system of knowledge, abilities and skills regarding the laws, conditions, processes and specific features of the foreign economic activity of the country, region, and enterprise, as well as the acquisition of skills for their practical use.

The tasks of the academic discipline are:

understanding the theoretical and methodological foundations of foreign economic activity, taking into account the requirements of world practice and national trends;

study of forms and types of foreign economic activity;

acquisition of practical skills in making managerial decisions on the development of foreign economic activity of the country, region, and enterprise.

The object of study of the discipline is the process of managing the foreign economic activity of the country, region, and enterprise.

The subject of the academic discipline is a set of economic, economic, legal, financial relations in the field of foreign economic activity.

Financial documentation in foreign economic activity.

Types of insurance: property, transport, personal, financial risks. International cargo insurance. Liability insurance of the carrier in the foreign economic activity. economic activity and methods of their insurance. Ways to minimize the risks of foreign exchange. Ensuring the foreign economic security of the enterprise.

TEACHING METHODS

In the process of teaching an educational discipline, in order to acquire certain learning outcomes, to activate the educational process, it is envisaged to use such learning methods as:

Problem lecture (Topic 1, 4,5,6,7,8), lecture-discussion (Topic 2,3).

Visual (demonstration (Topic 1-8)).

Practical and laboratory (practical work (Topic 1 - 8), case method (Topic 1, 4, 8), presentation (Topic 1, 2, 3, 4), individual research work (Topic 2, 5), work in small groups (Topic 3,7,8), situational modelling (Topic 5), document design (topic 6,7), business game (topic 6,7).

FORMS AND METHODS OF ASSESSMENT

The University uses a 100-point cumulative system for assessing the learning outcomes of students.

Current control is carried out during lectures, practical, laboratory and seminar classes and is aimed at checking the level of readiness of the student to perform a specific job and is evaluated by the amount of points scored: the maximum sum is 100 points; the minimum amount is 60 points.

The final control includes current control and assessment of the student.

Semester control is carried out in the form of a semester exam or grading.

The final grade in the course is determined: the final grade is the amount of all points received during the current control.

During the teaching of the academic discipline, the following control measures are used:

Current control: practical and laboratory tasks (75 points), control work (10 points), colloquium (15 points).

Semester control: Grading
