#### INTRODUCTION

The beginning of the XXI century. was marked by dynamic transformations in the world associated with the aggravation of the struggle between opposing trends in the development of society. On the one hand, globalization processes are spreading, which cover all spheres of human activity, and processes of international integration are developing. On the other hand, localization disintegration processes are increasing, which, paradoxically, are happening in parallel with globalization and integration. It is precisely in the realm of unity and struggle of these opposites that the development of countries takes place in our time. In this context, the compulsory academic discipline "Country Studies and Organizational Behavior of a Foreign Enterprise" acts as one of the leaders in the holistic understanding of the processes taking place in the modern world.

The purpose of the educational discipline is to form the basic knowledge and skills of the students to carry out a complex country-scientific analysis in the field of international economic relations.

The tasks of the academic discipline are:

- research on trends in the development of society;
- mastering the main features of foreign markets for further practical activities in the field of international business;
- studying the peculiarities of the organizational behavior of enterprises.

The object of study of the discipline is the transformation processes in the world from globalization to localized disintegration

The subject of the academic discipline is the regions and countries of the world with their multiple varieties, which affect the organizational behavior of a foreign enterprise.

## **TEACHING METHODS**

In the process of teaching the educational discipline "Local Studies and Organizational Behavior of a Foreign Enterprise" in order to acquire certain learning outcomes and to activate the educational process, it is envisaged to use such learning methods as:

Verbal: introductory lecture (Topic 1), review lectures (topics 2-8), problem lecture, discussion (Topic 3, questions of lecture 3.3, Topic 6)

Face-to-face: demonstration of presentations on topics 1-8, demonstration of film-video clips on topics: 1-8

Practical: practical work on topics 1-8, essay, individual task, role-playing game (practical work 3.2), didactic game (practical work 8.1)

### FORMS AND METHODS OF ASSESSMENT

The university uses a 100-point accumulative system for evaluating the learning outcomes of students of higher education.

**Current control** is carried out during lecture, practical, laboratory and seminar classes and is aimed at checking the level of preparedness of the education seeker of higher education for the performance of specific work and is evaluated by the sum of points scored:

- for courses with a form of semester control as an exam: maximum amount is 60 points; minimum amount required is 35 points.

The final control includes current control and an exam.

**Semester control** is carried out in the form of a semester exam or grading.

*The final grade in the course* is determined:

- for disciplines with a form of exam, the final grade is the amount of all points received during the current control and the exam grade.

During the teaching of the course, the following control measures are used:

Current control: Practical tasks (20 points), participation in a role-playing game (5 points), participation in a didactic game (5 points), written tests (14 points), essay (6 points), individual task (10 points).

Semester control: Grading including Exam.

### **Evaluation criteria**

**Final scores for the exam** consist of the sum of points for completing all tasks, rounded to a whole number according to the rules of mathematics.

The algorithm for solving each task includes separate stages that differ in complexity, time-consumingness, and importance for solving the task. Therefore, individual tasks and stages of their solution are evaluated separately from each other as follows:

# Task 1 (test). (5 points)

For each correct test - 0.5 points.

Task 2 (stereotype), (4 points)

2 points for each correct task

Task 3 (diagnostic), (19 points)

- 1 diagnostic task is evaluated in 5 points:
- 1 the ability to apply acquired theoretical knowledge in practice;
- 2 the ability to analyze the situation and choose the right solution to solve the problem;
- 2 formation of a consistent, structured and reasoned answer; availability of substantiated conclusions.
